Since the last meeting, the Town of Cortlandt has:

- 1. Extended a consultant service contract with Schnabel Engineering in the amount of \$160,000, to perform geotechnical investigation, survey and preliminary design, necessary to estimate the cost of reconstruction. As detailed design is progressed, estimates will be revised.
- 2. Passed a Town Board Resolution authorizing staff to apply to NYSDEC to obtain funding through the Federal Emergency Management Agency's (FEMA) High Hazard Potential Dam (HHPD) grant program:

- Created a website for this project containing past documentation, maps and a preliminary assessment role for a potential parks district. <a href="www.townofcortlandt.com/projects">www.townofcortlandt.com/projects</a>. Scroll to Westchester Lake / Wallace Pond.
- 4. Prepared correspondence to elected Officials and the Regional Director of the New York State Department of Transportation to determine if any financial assistance can be provided as Route 9 is directly downstream of the dam.

We look forward to discussing the above at an informational meeting scheduled via **Zoom, May 24, 2021 at 7:00 pm.** We encourage all property owners to attend this virtual meeting.

The Town will continue to assist the Westchester Lake residents in resolving the NYSDEC violation. With a commitment from the residents, the dam can be reconstructed in a manner that is beneficial to the overall health and quality of the lake while mitigating hazards in the event the dam is fully breached and fails.
