NOTICE IS HEREBY GIVEN, that pursuant to Section 175 of the Town Law the annual election of Fire District Officers for the Montrose Fire District will be held at the Montrose Fire House, 2143 Albany Post Road, Montrose, New York, on the 13th day of December, 2016 between the hours of 6:00 PM and 9:00 PM, Prevailing Time.

One Officer, Fire Commissioner, is to be elected, for a term of five (5) years commencing January 1, 2017.

Every elector who is a registered voter under personal permanent registration and a resident of the Fire District thirty (30) days next preceding the annual Fire District election shall be qualified to vote and to hold office.

The polls will be open for the receipt of ballots from 6:00 PM to 9:00 PM, Prevailing Time, on December 13, 2016.

PLEASE TAKE FURTHER NOTICE, that pursuant to Section 176 of the Town Law candidates for District Offices shall file their names with the Secretary of the Montrose Fire District at least ten (10) days prior to the date of such Fire District election, and in addition, such nominations shall be submitted in petition form subscribed by twenty five (25) qualified voters of the District.

All completed petitions shall be submitted and filed at the Montrose Fire House, 2143 Albany Post Road, Montrose, New York at least ten (10) days prior to the date of the Fire District election.
