SUPERVISOR'S PROCLAMATIONS & REPORTS

### Supervisor Puglisi gave her report. OF NOTE:

The meeting was regularly scheduled for February 12, 2019, but due to a winter storm it was moved to tonight. There were two public hearings held over from the January meeting. The public hearings will not be voted on or addressed this evening. They will be adjourned to the March 12, 2019 meeting.

Supervisor Puglisi attended a USO show at the VA Hospital on February 14, 2019 for Valentine's Day. George Latimer, County Executive also attended. There are pictures on the Town website.

There have been a lot of winter storms this month and she commented Steve Ferreira is now the Acting Interim Director of DES and has done a great job managing the storms.

The Town Website has a lot of interesting items and information for Town residents, for example a new Beautification Committee. It's an expansive website that was redone last year.

February is Black History month. There have been events in the community and most importantly give recognition to African American population, who have done so much for society, as well as in the Town.

The Washington St. Bridge has now reopened. Michael Preziosi, Town Engineer stated that it was completed ahead of schedule. Supervisor Puglisi thanked everyone for their patience and cooperation with this. Mr. Preziosi concurred, and added that the repair was about \$130,000, and will hopefully last 50 plus years.

Town finances will have some additional revenue this year, which is the fourth quarter 2018 sales tax. There will be a surplus. Patty Robcke, Town Comptroller stated they are anticipating for 2018 finishing the year with about a surplus of \$400,000 in sales tax. Supervisor stated it goes into the Town General Fund, and can be used for various community purposes.

Pondview Commons is a new development off of Rte.6/Cortlandt Blvd. Michael Preziosi, Town Engineer stated it is going to be constructed at the intersection of Rte. 6 and Regina Ave. There will be 56 new residential units with the extension of the Town water and sewer utilities. As part of their approval they contributed ¾ million dollars to the traffic signal at the Baker St. intersection. Supervisor Puglisi added that about \$370,000 will be benefited from this development, and different portions of this will go to different funds throughout the Town.

The County Executive is proposing an additional 1 percent sales tax to taxpayers, and has asked all Towns, and Villages to comment on this. The additional 1 percent sales tax will help Westchester Co. to be able to raise their low fund balances. It will also be divided up amongst all of the Villages, Towns, the County, and School Districts. Also, the Westchester Co. sales tax is lower than Putnam and Rockland Co. currently.

# **TOWN BOARD REPORTS**

# Councilmember Farrell gave his report OF NOTE:

The final MKW report for the Discovery Center at Cortlandt Waterfront Park will be filed tonight. Part of the vision of the park is reusing the historic seaplane hangars that are on sight. The Cortlandt Community Rowing Club was successful in receiving a grant for \$50,000 from the DEC to go toward the renovation.

Attended the Association of Towns meeting, and many Towns expressed concerns about State funding.

Town roads and state roads are in bad shape, particularly state roads, and wonder if it may have to do with the money spent to build the Tappan Zee Bridge. The Town will be focusing their attention on the roads. Albany Post Rd. (state road) will be repayed in conjunction with the sidewalk project, and would like to work with NYSDOT to ease traffic flow patterns on that road, and will be looking forward to working with Steve Ferreira on these paving projects.

# Councilmember Costello gave her report OF NOTE:

Announced she and Councilman Creighton attended the grand opening of Hudson Valley Ophthalmology.

Congratulated three new DES Laborers on joining the Town of Cortlandt Family.

# Councilmember Becker gave his report OF NOTE:

Attended the Association of Towns in Manhattan last week. Many Towns concerned about State Aid and tax cap. The Town has always been well below the tax cap, and State should put a tax cap on themselves rather than pass it down to the municipalities. Other Towns concurred.

# Councilmember Creighton gave his report OF NOTE:

Reminded non-profits and Senior Citizens that the tax exemption application deadline is May 1<sup>st</sup>. Starting in 2019, NYS Law provides that they must apply for the exemption. It will not just roll over, as it had in the past. Please see Tax Assessor if you have any questions.

Attended the Association of Towns, and found it very helpful, and training to be critically important. The training was especially helpful and included the Overdose Prevention funding plan, Collective Bargaining, Ethics, LED Smart Street lighting, and much more.

Joe Scordato a great friend and neighbor passed away at 93 years old. He was a Town resident for over 60 years and loved his Cortlandt neighborhood, Evergreen Knolls, and will be truly missed.
