# **MEETING CALLED TO ORDER**

Supervisor Puglisi called the meeting to order at 7:00 p.m.

<u>Supervisor Puglisi</u> stated that they will proceed with the adjourned Public Hearing of Cortlandt Crossing of the application from Arcadia.

# **PUBLIC HEARINGS**

# RE: Reconvene a Public Hearing to consider the Draft Environmental Impact Statement with respect to Cortlandt Crossing; and a Legislative Public Hearing with respect to same.

(A complete transcript of this Public Hearing is on file in the Office of the Town Clerk.)

The Town Clerk read the Notice of Hearing and presented its Affidavit of Publication from the official Town newspaper.

**Supervisor Puglisi** called the hearing to order at 7:08 p.m.

The **Supervisor** explained the location of the property on Rt. 6 across from the Cortlandt Town Center and its several owners. She stated that during the hearing the Town Board will listen to the comments and questions and everything will be answered in a Final Environmental Impact Statement.

Tom Wood explained, as they did last month at the first meeting, the application process and for adjusting the zoning map. When it is presented, a determination has to be made as to what agency plays the most significant role in the process. In this case it was determined that the Town Board plays the most significant role and the Town Board is the lead agency to coordinate the process. The purpose of the public hearing is to afford the public the opportunity to raise questions or concerns. There will also be public hearings in front of the Planning Board and then the Town Board will make decisions regarding the legislative actions and other actions that would have to take place. This is a very open process and he stated that any issues that are identified this evening must be addressed by the applicant in one form of another.

**Supervisor Puglisi** added that they had asked the applicant to meet with a few residents who had more questions. She then turned the meeting over to David Steinmetz, law firm for the applicant.

Mr. Steinmetz stated that they sent out another mailing to the community responding to anyone who contacted him and to the neighbors in the vicinity as part of a continuing dialogue that Arcadia is prepared to have with the community.

Stated that he is directly impacted by the application. He proceeded to read the letter (A complete transcript of this letter is on file with the filed minutes) regarding rezoning.

# <u>David Wald</u> 49 Conklin Avenue

Here to support this project. The intent of this process is to have a dialogue over an extended period of time to fine tune the proposal. He stated it is not the developer's job to "save the Town" as commented by Mr. DeBenedictus. The job is to ensure that the property is developed in such a way that it will be a benefit and an enhancement to the Town. The existing businesses are not victims, they've known this might be happening for many years and many of the residents living there want to see improvements.

David Steinmetz asked that the Public Hearing be closed and leave a public comment period open as state law requires. He stated that they are anxious to take the comments heard from the public and papers from the Town and begin the final preparation of the final FEIS.

Tom Wood commented that there would be a 30 day written comment period from the residents and the applicant is required to respond. All the other agencies involved will be conducting a series of public hearings and comments and these comments will also be part of the SEQUA record.

A motion to close the Public Hearing at 7:38 p.m. was made by Councilmember Becker and seconded by Councilmember Freach.

### **SUPERVISOR'S PROCLAMATIONS AND REPORTS**

**Supervisor Puglisi** commented on the amount of snow this year and thanked Jeff Coleman and his staff for their work.

The **Supervisor** spoke of the events: Martin Luther King Jr. Day and President's Day and hoped to see the Lincoln Depot Museum in the City of Peekskill.

John Federspiel, President of Hudson Valley Hospital, notified the Town that they are now affiliated with New York Presbyterian Hospital and it is now officially called New York Presbyterian/Hudson Valley Hospital. There will be more physicians, more staff and services to the community.

More businesses have opened up at the Cortlandt Town Center; Moe's Restaurant, Children of American Childcare, and Starbucks across from Curry car dealership.

Eaglefest was held this past Saturday with about 200 participants at Verplanck and there were about 54 eagles that were sighted.

The Town Board is doing their best to fight Spectra/Algonquin gas line from 26" to 42" and its proposed location. It is not known what the FERC decision will be but the Town is doing its part on behalf of the residents. They will be purchasing the Con Ed property and that will stop the other impact to the community by West Point Partners, but FERC supersedes local Town government.

Sara Nolte 61 Dogwood Road

Respectively disagreed on the state of the roads for the storm the previous Sunday. She spoke of her daughter having an accident that day on Red Mill Road at 4:00 p.m. because the roads had not been "touched" at that point. She asked why they hadn't been done and still not done by 8:30 p.m.

Jeff Coleman responded that they had been monitoring the storm event all day and discussed the condition with Ms. Nolte. Tim Nolte asked about what the time is that the Town goes out to

sand the roads. He asked if it was a matter of overtime to which **Supervisor Puglisi** answered that it was not.

**Supervisor Puglisi** apologized stating it would not happen again and will be addressed more. Mr. Nolte also discussed the towing fee that was charged as Cortlandt does not have guidelines as far as what tow companies can charge, as Peekskill has. Tom Wood indicated that the State Police are in charge of that, not the Town. Mr. Nolte asked about the fee schedule that the police have to which Tom Wood stated that the Town is not involved as they do not have a police force and that the Town cannot mandate their fee schedule.

Councilmember Farrell asked Mr. Nolte what the other tow operator was going to charge. Mr. Nolte indicated it would be free or he would have done it himself. Mr. Nolte felt it was price gouging and was told to speak to the Town.
