Supervisor Puglisi called the meeting to order at 7:30 p.m.

## SUPERVISOR'S PROCLAMATIONS AND REPORTS

Supervisor Puglisi introduced the Scouts who ranged from ages 12 to 16 years old and were attending the Town Board meeting towards being awarded their Communication Badges.

The **Supervisor** reminded the residents that Sunday, July 28<sup>th</sup> the 225<sup>th</sup> Anniversary of the Town of Cortlandt will be celebrated at the George's Island Park. The celebration will include a parade and a fireworks display. County Executive Rob Astorino

Supervisor Puglisi stated that on February 28th at 6:30 p.m. there will be a presentation by NYS DOT regarding the improvements being started on the Bear Mt. Parkway for the community to view the plans. There will be input from the community but the plans are prepared and the work will be completed in 2013. The Town of Cortlandt does not have to contribute to these improvements.

#### **SUPERVISOR'S REPORTS**, (cont.)

The **Supervisor** attended the Governor's Moreland Commission at Purchase College to state the many issues with the unsatisfactory response by Con Edison before and during Hurricane Sandy. They are hoping that something positive will come out of this meeting.

She also attended with Nita Lowry to speak with the NRC Chairperson for the purpose of asking NRC about their upcoming decision on Indian Point and about the re-licensing. They told the Supervisor they would most likely not render a decision this year in 2013, most likely in 2014 or 2015.

There will be a second meeting with Con Edison's President, Mr. Ivy, in order to learn about the improvements and new practices that Con Ed will implement after hearing from all the municipalities throughout Westchester County.

Later this month the Town Board will be holding a special Town Board meeting to award a contract for the Furnace Dock Lake Dam repair. Con Edison agreed to pay for the repair of their dam when the Town bought the lake. There will also be a bid awarded for the Cortlandt Boat Launch at the Cortlandt waterfront park in Verplanck.

**Supervisor Puglisi** thanked the Scouts, their leaders, and parents for attending the meeting and commented that it is a terrific organization.

#### **TOWN BOARD REPORTS**

<u>Councilmember Farrell:</u> Reminded the residents that the Town of Cortlandt has a Youth Center located in Crugers and would like to encourage the residents to make use of the building. **Councilmember Farrell** asked that the scout troops also can use it for any special meeting they might have and just to call the Supervisor's office to arrange the date. There is a kitchen for preparing meals, a rock climbing wall, pool table, exercise table and other equipment for use. A rowing machine was just placed there and it's something that is used by athletes to practice the sport of rowing.

**Councilmember Farrell** met with a group of people who are interested in forming an amateur rowing association. Their plan is to repurpose one of the hanger buildings at the seaplane base, now the Cortlandt Waterfront Park in Verplanck. The plan is for an amateur rowing group to take over one of the buildings, make it into a boathouse, have some rowing boats there and gradually grow to a point to offer the program to the schools. **Councilmember Farrell**

stated that it is the kind of sport that boys and girls can do using the same equipment and is a sport where there is a lot of scholarship money available.

There will be a boat launch which will be used for the rowing association but not for the exclusive use of the association. People can take kayaks, canoes, etc and launch from the dock. The dock will be small and the area is limited so the size of the boats used will be determined.

**Councilmember Farrell** complemented the DES and the job that was done in clearing the latest snow from the roads. By Saturday the entire Town was clear.

Councilmember Becker: Stated that Jeff Coleman tonight will be appointed as official Director of DES and complemented him on his work. Councilmember Becker also stated that James Creighton will be appointed to the Planning Board and commented that the Planning Board is important in that it defines what the nature of this Town's environment will be going forward. There was a very interesting interview process and Councilmember Becker stated that the quality of the applicants was outstanding. There was only one opening but that all were very qualified and Councilmember Becker hoped they will get involved in the Town. Jeff Canning will also be appointed this evening as a historical advisor. He noted that the Town has a very rich history and that it would be a shame to not preserve or recognize it.

<u>Councilmember Sloan:</u> Commented that though it is a good thing for the improvements on the Bear Mt. Parkway, the DOT is not going about it in a good way. He spoke of the plan to reduce it from two lanes to one lane, and **Councilmember Sloan** said this would increase traffic. He stated that this is a very easy thing for DOT to do which is why they agreed so quickly.

**Supervisor Puglisi** asked for everyone to keep an open mind and that the safety of the corridor is most important and if it takes longer, so be it. **Councilmember Sloan** commented that they could do both, increase safety and no reason why the Town should accept only one at the sake of the other.

**Supervisor Puglisi** added that there will still be no truck traffic on the road during the day.

The **Supervisor** had thought that the public electric car stations should be something the Town should consider, perhaps near the Cortlandt Train Station or elsewhere and have a pilot project to obtain grants.

**Councilmember Farrell** stated that at one time it seemed like a good idea to standardize the trucks within the department because there was a real hodge podge of different makes and it would make more sense from a maintenance standpoint to standardize. However, Jeff Coleman felt it would have the effect of locking the Town into purchasing vehicles which were not best suited or priced. Councilmember Farrell commented that it seemed to be a good idea.

The **Supervisor** stated she always thought it might be interesting to explore the possibility of an outdoor Olympic sized Volleyball court. They will be looking at areas for construction.
