MEETING CALLED TO ORDER

Supervisor Puglisi called the meeting to order at 7:00 p.m.

Supervisor Puglisi led all in attendance in a Pledge to the Flag.

SUPERVISOR'S PROCLAMATIONS AND REPORTS

<u>Supervisor Puglisi</u> spoke of the many events of the past month. These included several Memorial Days ceremonies which can be seen on Channel 78 and the Town's website. Also the Mt. Carmel's Society's picnic honoring all veterans and current service men and women was held and is the same organization that will have the Feast in July. Flag Day was June 14th, officially designated by President Harry Truman and the 70th anniversary of D-Day when 160,000 allied troops, including the late Town Councilman Michael Mongero, landed on the beaches of Normandy. More than 9000 solders lost their lives or were wounded and which led to the end of World War II.

The **Supervisor** also attended New York State Senator Greg Ball's Woman of Distinction Award Night. The Cortlandt nominees Lea Olsen and Jenny Schutrek were honored, the **Supervisor** commenting that they were very well deserving of this tribute for all they do.

SUPERVISOR'S REPORTS, (cont.)

The Town's pool is open and the **Supervisor** wished everyone a very wonderful and safe summer season. The crews have been working very hard to put the pool together and she thanked Jeff Coleman and his crew.

The **Supervisor** announced that at the Town's Youth Center there will be a full court basketball court. That construction is on the way now and will be completed in about two weeks.

The Town's Paving Bid will be awarded in July and will begin late August/ early September. Over one million dollars will be allotted for paving this year, last year about 1.5 million dollars. Potholes have and are being filled and litter is being picked up. The seasonals, who are all Cortlandt youth, have been hired to help with this work.

Supervisor Puglisi stated that she attended a forum put on by Assemblywoman Sandy Galef regarding a property tax freeze. The **Supervisor** was asked to speak on shared services; something the Town has had many successes in the Town. This is done to save the taxpayers money. She also attended a forum by Congresswoman Nita Lowy to speak about the prevention of substance abuses, especially the heroin epidemic everywhere. **Supervisor Puglisi** also spoke at that forum discussing what she and the Town Board and the staff are doing to educate the community on that important subject.

The new medical drop off box which is located at Town Hall has had over10 lbs. of medical tablets, etc. picked up safely by the Westchester County Police. The **Supervisor** thanked them and everybody else who was involved in that endeavor. She urged residents to use this drop box for their expired medications.

The **Supervisor** was invited to attend and have the honor of going to Cortlandt resident Virginia Reed's 100th birthday and presenting her with a proclamation.

The Shop, Dine and Do Business Month was a huge success and that was to bring attention to doing business locally. The **Supervisor** added that everyday in Cortlandt is shop, dine and do business locally and urged residents to help out the local businesses.

June 1, 2014 officially began this year's Hurricane Season. The **Supervisor** brought this up as they already put the information out and linked it to Westchester County Emergency Services and to Con Edison. They give key factors of what to do in case of a hurricane. **Supervisor Puglisi** emphasized that it is very important to register cell phone numbers and emails in the **Supervisor's** office to provide with immediate emergency messages, such as Code Red. This is totally confidential only used for to give residents important emergency messages.

There have been a lot of discussions regarding opposing a large energy company that wants to come into Verplanck called West Point Partners (nothing to do with West Point). They want to build a large transformer on Con Edison property. The **Supervisor** stated that the Town already have and has done enough for energy in the community and do not need to become the energy capitol of New York or the country. She commented that this building would impact residents,

schools, children and the quality of life in our community. The Town is opposing it and having a rally tomorrow night in Verplanck and urged residents to attend.

The Town is also opposing the large expansion of the Spectra/Algonquin gas pipeline. They want to expand and reroute it and it goes within 500 feet of the Buchanan/Verplanck Elementary School. The **Supervisor** stated we are against that happening and fighting this with Buchanan.

TOWN BOARD REPORTS

<u>Councilmember Costello:</u> Stated that residents of all ages will be welcome at the rally and they hoped the media would show up and let everyone know that they are against the West Point Partners and Spectra pipeline. Councilmember Costello urged the residents to attend and hopefully they have heard about it. She stressed that it's just not something in Verplanck and Buchanan, that it will affect everyone in the Town of Cortlandt. She encouraged residents to learn about it and come to the rally.

Councilmember Costello commented that she did a ribbon cutting for the opening of GNC in the Cortlandt Town Center and her and Councilmember Freach both attended the new restaurant in Verplanck, Ralph and Dave's. She encouraged everyone to shop locally and visit the new restaurant as well.

She gave kudos to the Montrose Firemen for their great bazaar once again and parade enjoyed by so many people. Councilmember Costello urged residents to find time to volunteer in any capacity available, a great way to give back to the community and help others.

Councilmember Becker: Had the opportunity to attend two Planning Board meetings this month concerning Abby Rose, a development that has been proposed for going on 20 years. It is at the top of Dickerson Mt., 120 acres of pristine land, wetlands, and two lakes. The developer proposed many homes on these 120 environmentally sensitive acres. After many years, this project was turned down because of its environmental impact on the community. It had been whittled down to 27 homes and the developer filed an article 78 and sued the Town. The NY State Supreme Court upheld the Town's decision. The property has sat and the owner has accumulated debt and taxes. Negotiations proceeded and there is now a tentative deal where the owner will give 106 acres for open space and he will develop 5 homes. The Town feels it is a very good deal for the Town and is in the hands of the Planning Board.

TOWN BOARD REPORTS, (cont.)

Supervisor Puglisi thanked Councilmember Becker for his work on this project to control development in the area.

<u>Councilmember Freach:</u> Chose not to reiterate what the Supervisor has already discussed, but wanted to revisit the medical drop off box. Councilmember Freach stated that this is a resource that over 10 lbs. of medication has already been turned in that would have been sitting in someone's medicine cabinet where others can find them. As we are continually facing the heroin epidemic, it is important to be diligent and do what we can to make our community safer. He thanked the County Police for operating it for the Town and is a great tool to keep our community safer.

Councilmember Freach also urged residents to attend the rally in Verplanck.

<u>Councilmember Farrell:</u> Remembers when Cook Pool was known as Pine Lake and stated that if you haven't been there, you owe it to yourself to check it out. It is a beautiful amenity for this Town, great lifeguards, snack bar, shallow pool area for kids, and is just a really nice place.

Councilmember Farrell wanted to recognize and thank the DES for some work recently completed on Washington Acres on a drainage project. Decades ago detention ponds were created and a drainage system was set up to transfer water through the area and to alleviate flooding. Through the years some filled in, pipes got clogged and after an assessment and work performed, they are now functioning properly. This was performed in cooperation with Westchester County using their equipment and was another example of shared services.

He also attended an Eagle Scout Award Ceremony for Jeffrey Quist, a Montrose resident and member of Scout Pack 36. Councilmember Farrell commented that it makes you happy to see young people who really have their act together. Jeffrey had completed many merit badges in his scouting career and is now an Eagle. For his Eagle project he installed Stations of the Cross at St. Christopher's Church.

Councilmember Farrell spoke of a recent news story of Sergeant Bergdohl, captured and held by the Taliban and then released in a controversial exchange of prisoners. The army appointed Kenneth Dohl, a Cortlandt resident who attended Walter Panas High School, to investigate this incident. Councilmember Farrell commented that he was very proud to know a fellow of that rank and distinction is one of our native sons. He also is a graduate of West Point.

Supervisor Puglisi also stated that she was discussing the next phase of DARE with Cliff Gabrielson, DARE officer, who is retired. His son is going to West Point in September.

The **Supervisor** also stated that next year a water spray park will be constructed at the Town Pool. Also, regarding conserving energy, the Town received a grant to have an electric car outlet station at the Town Hall, being the first community to have this distinction. Jeff Coleman gave information regarding the charging station stating that it is for plug in electric vehicles. Once all details are worked out there will be a sign up and all rules and regulations will be displayed.

HEARING OF CITIZENS, (AGENDA ITEMS ONLY)

Mike Morey Resident of Peekskill

Thanked the Town for their responsiveness for this matter of speeding on Dimond Avenue. He lived on Dimond when he was young when the street was a cul-de-sac before Cortlandt Estates was built. With the development of Cortlandt Estate has come many challenges, most importantly the traffic that comes off of Rt. 202 onto Dimond becoming a drag strip. More often it is the adults that are going too fast. Mr. Morey stated that the tensions are getting high among the residents of Dimond Ave. and Cortlandt Estates. The speed humps have been helpful but the problem with their location is that they're at the entrance of Cortlandt Estate and then some. On the old part there are no traffic calming devices. Mr. Morey presented a petition from the residents to put in multiple speed humps.

Supervisor Puglisi stated that Jeff Coleman put out the smart machine. Jeff explained the smart machine to the residents and that it will be there as a deterrent to the drivers. A letter will go out to the neighborhood to ask that the residents be cognizant of the children in the neighborhood. The County Police were notified and has assured that speeding patrols will be stepped up. The Supervisor explained the order of procedure for the petition and that the building of the speed bumps will be expedited.

Ruby Horton 18 Dimond Avenue

Stated that the black strip had been torn but replaced so you cannot count from Thursday to Monday. During the day speeders and tractor trailers use Dimond to get to Cortlandt Estates. Ms. Horton asked for "bumps" not "humps" but Jeff Coleman answered that they cannot place bumps on the road because of state law.

The **Supervisor** stated that they hear the residents and will expedite solutions.

Ms. Horton asked if the speed limit could be changed? Tom Wood answered that by state law the lowest the Town Board can do is 30 mph unless after traffic study petitions sent to the state Commissioner of Transportation with reasons to be lowered is considered.

Supervisor Puglisi and Ms. Horton discussed how many additional speed humps should be considered and decided at least two should be placed.

Sergeant Ed Devlin Westchester County Police

Commented that they do hear the residents and over the years they've worked with the Town to address many neighborhoods with this issue. The idea is to change behavior and to slow people down. He stated that they want people to understand the reason they are slowing down and not just because there is a speed limit sign. Sgt. Devin promised to add this to the list of selected speed enforcement to address these concerns.
