MEETING CALLED TO ORDER

Supervisor Puglisi called the meeting to order at 7:00 p.m.

PLEDGE TO THE FLAG

Supervisor Puglisi led all in attendance in a Pledge to the Flag.

SUPERVISOR'S PROCLAMATIONS AND REPORTS

<u>Supervisor Puglisi</u> spoke of the many plans and projects during the past month including the new Master Plan which will be looking at ways to bring in an indoor ice skating rink to Cortlandt. All the Town Board members are working on their own special projects and there has been a wonderful transition with the new Town Board members, Seth Freach and Debra Costello.

The **Supervisor** commented on a sad note of the passing of two young men in the community and how the Town Board is committed to doing all they can to prevent substance abuse. They've spoken with the police and the **Supervisor** has been asked by the Hendrick Hudson School Superintendent to co-host a community forum with speakers educated in this field at the end of February. Details will be on the Town's website.

Expenditures for the frequent snow and ice have doubled with over 18 snowstorms this year. The Town is fortunate to have the funds without having to borrow. They have been able to pay for the storms which are why they've always made sure that they have that money for emergencies.

SUPERVISOR'S REPORTS, (cont.)

Supervisor Puglisi thanked the employees who have worked hard to clear the snow and ice in the community through all times of the day and weather conditions. She also thanked the residents for their cooperation during the difficult weather in keeping their cars off the road for the plows. The school districts make the right decision to keep the students home during these snow days.

This past month the community has lost Captain Clayton Carpenter, a Cortlandt resident who came home after his tours of duty and lost his life in a helicopter accident. The **Supervisor** expressed sympathies to his family and friends as well as the two deaths previously mentioned.

On a roll call attendance taken by Town Clerk Dyckman all Town Board members indicated their presence.

TOWN BOARD REPORTS

Councilmember Costello: Asked that the residents consider coming to the High School to the forum regarding the heroin issue in the community. There will be many different groups of people there to answer questions. She thanked the Superintendent of the High School, Supervisor Puglisi and the Town Board for their support in this program. Councilmember Costello hoped that residents will come with questions that can be answered and this will help to start a dialogue so people can discuss more with their families and be educated on the issues going on regarding drug abuse in our community. She asked that they bring hope, compassion and questions to the meeting as it is very important.

Councilmember Costello welcomed new people into our Town Government and wished them well. She thanked all of the Town employees who have been involved in the winter cleanups and commented how they have worked the weekends and holidays that we all look forward to.

Councilmember Becker: Also spoke of his concern with the heroin epidemic in the community and how he wasn't aware of the scope of this issue in the community and it is reminiscent of the 90's with the crack cocaine issue. He explained that what has happened is that young people get addicted to pain killers, but these are expensive and controlled, so what happens is that because heroin is so much cheaper and available, the kids turn to that. This heroin is not pure but mixed with other ingredients and very potent and causes death. Councilmember Becker stated that this is not an inner city or racial problem but across all socioeconomic groups and he is frustrated by the lack of an idea of how to approach this except by coming together as a community and getting

educated about it. He thanked Councilmember Costello and Supervisor Puglisi for bringing it to the attention of the Town Board to be pursued.

Councilmember Becker participated at the Eagle Fest events that were around the Town. He commented he never imagined he could go to 4-5 different points along the Hudson and be with experts with spotting scopes and see so many bald eagles. He urged residents to bring their children to the event next year.

Supervisor Puglisi congratulated Councilmember Becker on his new position at Phelps Hospital.

<u>Councilmember Freach</u>: Thanked the DES employees and Town employees with regard to the storms this particularly bad winter.

Councilmember Freach also touched upon the events of the past few weeks regarding the heroin epidemic in the community. He commented that unfortunately this is not a new problem; that it is now having a light shined upon it and he is glad it is being discussed. Concilmember Freach commented that it needs to stay in the forefront of our minds even after it is no longer on the front page of the news. He advised that residents check their prescription pills that are in their house to review and should discard what is not necessary. He wants to reiterate that this Board is committed to addressing this head–on, working with the police and schools to initiate programs to make an impact and change.

Councilmember Freach also spoke of the Solar Task Force that the Town Board approved last month. Letters to experts have gone out and residents to gauge interest and get feedback on how to proceed and Councilmember Freach stated he was happy to report that the feedback has been positive. Meetings will be set up soon.

Councilmember Farrell: Also stated that the community and nation is facing a confounding problem with the heroin issue. Councilmember Farrell commented that the country is spending 50 billion dollars a year to combat the "war on drugs" yet obviously not very successful. Whatever the Town Board can do they will do. Councilmember Farrell spoke of 2 stories in the paper of a doctor of prescription pills as compared with a young man who received 40 years for sale of another drug and the disparity of the two.

Councilmember Farrell commented about municipalities having trouble getting salt for the ice due to the recent storms. The sand is being cut with sand which is effective but is a cleanup problem in the spring. Over 1 million dollars has been spent so far and that will have an effect on the summer operations. The men and the equipment have been taxes to the breaking point and there have been many breakdowns, so a great deal of credit goes to the mechanics and drivers who worked to keep everything running.

The Town is looking at all the Youth programs and looking at the Youth Center which they are hoping will be used more than it is now. They would like the kids to use all the

facilities in the Youth Center and they need to tell parents that these activities are available and that they would like them to use them.

Councilmember Farrell stated that the Town is very supportive of, yet not a Town activity, a rowing club forming in Verplanck. More information is to come but it seems to be taking off very well with the Town's support letting them use a building on 7th Street in Verplanck for winter training and other areas used for training. If anyone would like to get involved with this, Councilmember Farrell advised them to go to the website and see the schedule which is open to residents and non-residents to appreciate the river and the lake.

<u>Supervisor Puglisi</u> commented that the million dollars for the winter costs includes all the factors of the snow storm removal. She stated they are fortunate to have the surplus highway fund to cover the cost.

They rented a house for a youth center which was then the Kaufman property and this was the origin of the Youth Center with the idea of getting the kids off the street and having a qualified person to monitor it. The Supervisor stated that they need more youths to go to the Youth Center to take part in all the great programs offered there.
