Dear Ms. Taylor and Members of the Planning Board:

The New York City Department of Environmental Protection (DEP) has received the Public Hearing Notice for the above referenced project.

The project site is located in the New Croton Reservoir drainage basin of New York City's Watershed, and the proposed action involves parking trucks and the storage of utility materials including utility poles, transformers, etc. for Northline Utilities on the above referenced parcel.

Based upon the review of the documents received - correspondence to the Planning Board and Site Development Plan both prepared by Cronin Engineering, and dated February 22, 2017, DEP offers the following:

DEP requested in its January 12, 2017 response letter to the Town Engineer that the 300' limiting distance as measured from the reservoir spillway elevation of the New Croton Reservoir be shown on the site plan. Accordingly, the Site Development Plan has since be revised and shows the 300 foot setback as requested.

When the Environmental Assessment Form (EAF) was originally circulated to DEP in December of 2016, it was DEP's understanding that the "contractor's yard," as noted in the project description would be for the storage of new equipment. However, according to the most recent submission, it is now understood that the storage of equipment includes "older transformers" that contain waste oil. As such, the proposed Northline Utilities contractor's yard meets the definition of a solid waste management facility as defined in Section 18-16 (105) of the Rules and Regulations for the Protection from Contamination, Degradation and Pollution of the New York City Water Supply and Its Sources (Watershed Regulations).

Furthermore, Section 18-41 of the Watershed Regulations prohibits the siting of a solid waste management facility within 1000 feet of a reservoir. Since the proposed action is well within 1000 feet of the reservoir, as shown on the Site Development Plan, this activity would be prohibited.

 According to the letter from Cronin Engineering, an infiltration trench is being provided for stormwater management. This area may be considered a hot spot in accordance with the NYS Stormwater Management Design Manual and, as such, infiltration would not be appropriate.

Moreover, the site plan also indicates the predominant soil type on site are Udorthents, which are classified as moderately drained. The detail for the proposed drainage cutoff trench shows that it is lined with filter fabric and will accommodate 25% of the water quality volume. Typically for redevelopment sites, a stormwater management practice is sized for the runoff from the area tributary to the practice, not a portion of that runoff, thus it may be undersized as per Chapter 9 in the Design Manual. Furthermore, the filter fabric type should be specified in order to demonstrate that the trench will function as intended.
