RESOLUTION

Number <u>36-11</u>

(RE: Declaration that Certain Roads in the Town be classified as Town Highway Pursuant to Section 189 of the Town Law – Adopt final Section 189 Listing Pursuant to Local Law No. 19 adopted December 14, 2010)

WHEREAS since the founding of the Town of Cortlandt in 1788, various roads have been created and constructed. Many of the original roads began as dirt paths over which the public traversed. In the 1800's the New York State Legislature established a provision in the Highway Law which has been carried forward and is now contained in Section 189 of the New York State Highway Law, "Roads by Use", which allows the municipality to accept private roads as public roads subject to various exceptions as described herein.

WHEREAS in 2008, the Town Board directed staff to study all existing 189 Roads and all those roads that should be considered as future 189 Roads. After much review and consideration, the Director of DES, The Director of DOTS and the Town Attorney recommend that pursuant to Section 189 of the Town Law, the roads set forth in the attached "Schedule A" are determined to be deemed to be highways by use in the Town of Cortlandt; and

WHEREAS, as part of extensive study of the 68 existing 189 roads, the staff found several errors or missing data such as length/width calculations in the record on 12 of the 68 roads already adopted as Section 189 roads (see attached Schedule B) and the Town Board wishes to correct the record, therefore the roads set forth in "Schedule B" are deemed to be highways by use in the Town of Cortlandt; and

WHEREAS, the Town Board wishes to consolidate the record into a single resolution addressing ALL Section 189 Roads in the Town of Cortlandt. The Town Board does hereby determine that all of the roads contained in Schedule A & B meet the criteria for a Section 189 road including that they have been used by the public for a period of ten (10) years or longer and the Town has performed certain maintenance there on in the form of patching or plowing during a period of at least ten (10) years; and

WHEREAS the Town shall continue to keep the traveled way in its current documented condition for the width and length the determined by the Town (as noted in Schedules A & B) over which a Surface Easement has been acquired, in a passable condition for the public to be able to traverse said roadway; and

WHEREAS by the adoption of this Resolution the Town Board directs the Department of Environmental Services to conduct a photographic record (either video, photos or both) for ALL of the roads contained on Schedules A & B to document their current condition within 180 days of the adoption of this Resolution.

NOW, THEREFORE BE IT RESOLVED that the Town Board does hereby DECLARE THE ANNEXED ROADS CONTAINED IN SCHEDULES A & B AS HIGHWAYS BY USE; and

BE IT FURTHER RESOLVED, that the Town Board of the Town of Cortlandt does here by direct the Town Attorney and the Director of the Department of Environmental Services to make application to the New York State Department of Transportation, pursuant to Section 171 of the Highway Law of the State of New York, to obtain a Certificate of Necessity declaring any and all the annexed roads to be public highways in the Town of Cortlandt.
