LAKE MOHEGAN FIRE DISTRICT ELECTION

PLEASE TAKE NOTICE that the Annual Fire Commissioners Election for the Lake Mohegan Fire District will take place on December 14, 2021, between the hours of 6:00 PM and 9:00 PM at one of two polling stations listed below.

Town of Yorktown residents that reside within the Lake Mohegan Fire District will vote at the Jefferson Valley Fire Station located at 500 Lee Blvd., Yorktown Heights, NY or

Town of Cortlandt residents that reside within the Lake Mohegan Fire District will vote at the Hollow Brook Fire Station located at 1130 Oregon Road, Cortlandt Manor, NY

The purpose of this election is to elect one Commissioner for a 5-year term, commencing January 1, 2022 through December 31, 2026.

All duly registered residents of the Lake Mohegan Fire District shall be eligible to vote. You must register with the County Board of Elections by November 22, 2021.

This year due to COVID-19 restrictions and regulations, the use of petitions has been suspended. In lieu of petitions, any resident of the Lake Mohegan Fire District, that is at least 18 years of age, who wishes to be a candidate for the Fire Commissioner election must submit a signed Letter of Intent. The signed Letter of Intent must be delivered to the office of the Secretary of the Lake Mohegan Fire District at 1975 East Main Street, Mohegan Lake, NY by November 24, 2021.

All candidates must be registered voters and reside in the Lake Mohegan Fire District for at least 30 days prior to the election.
