SECOND HEARING OF CITIZENS

Wayne Callie

17 Riverview Ave, Verplanck

Asked questions regarding an eviction notice he received. Tom Wood, Town Attorney, explained the title policy of the property and the life estate of Jim Martin regarding his property and the vacating of homes after a 10 year period.

Mr. Callie questioned the deed for the property and was advised to go to the Westchester County Clerk's office if the title to the property is in question.

<u>Supervisor Puglisi</u> introduced George Latimer, Westchester County Executive and thanked him for all his help during the difficult time of the Nor'easter.

<u>George Latimer</u> <u>Westchester County Executive</u>

Spoke of an Executive order regarding a "Good Neighbor Policy" and to give a letter to support the request for money for the Indian Point closure.

The Executive Order basically is about the fact that the County government has been allowed to act in any County owned property or facility and so now the County would have to come before the local Board and make a formal presentation. The Town has a chance to assess what the impact of that action would be on the Town. At the end of 60 days a letter of support or opposition would be presented and then the action would be reconsidered. This guarantees the Town a "seat at the table" regarding what will occur in their Town of significant issues.

HEARING OF CITIZENS, cont.

Town Board Meeting

Supervisor Puglisi commented that they share the services of the County Police. Comptroller Patty Robcke and the Supervisor are working with the Rockefeller Institute to help develop shared services which saves money for taxpayers.

Councilmember Farrell thanked County Executive Latimer and expressed excitement and gratitude to the County for the investment in George's Island of 4 million dollars over the next several months.

Councilmember Creighton stated they've been discussing shared services with the mayor of Peekskill and other communities. Camp Smith is a gray area and that is a state agency so the Town would like to get it clarified or to push Camp Smith as a qualified entity for shared services.

Marc Lawrence

Spoke of the asbestos investigation. Tom Wood replied that the result was that there were no issues and he explained that proper protocals were followed.

Questioned the leaking of the new water tank. Tom Wood replied that the company is addressing these common leaks.

Discussed the investigation of being a threat and being out of work. Tom Wood replied that they followed the process of evaluation.

Tom Wood commented that they will address his issues at an August 23rd meeting when Mr. Lawrence is back from vacation.
