ROLL CALL

On a roll call attendance taken by Town Clerk Shatzkin all Town Board members indicated their presence with the exception of Councilmembers Creighton who arrived at a later time.

BID REPORTS

1. TE Contract 2018.05 Charles J. Cook Pool Bath House Demolition and Reconstruction; Award same.

Councilmember Becker moved that the following resolution be adopted, seconded by Councilmember Farrell

RESOLUTION NO.229-18 RE: Authorize an amendment to reject all bids regarding the Demolition and Reconstruction to Charles J. Cook Pool Bath House and direct the director of DOTS to redesign and submit updated estimates.

Discussion: Supervisor Puglisi commented that everyone was extremely disappointed and shocked about the numbers, thinking they'd come in around 2.2 million but instead came in about 4-5 million. The Supervisor stated she was very disillusioned with the architect and that the original budget was not to exceed 1.5 million. Councilmember Costello noted that the Town has already spent \$150,000 on current design. Supervisor Puglisi directed Michael Preziosi and staff to redesign a more reasonable design in the ballpark of \$500,000. Councilmember Becker stated they were all in agreement and asked Michael for the original scope to review. Supervisor Puglisi commented that the number could not be justified for 20% of the community and 2 months out of the year. She added they do not want to rush and they are now looking basically for a "facelift". Councilman Farrell commented that many repairs could be done in-house at a lower cost. Both Councilman Farrell and Becker commented that they would like to be more involved in the planning and development of a new design. All agreed that they have now a plan to reconsider and will not rush the process.

2. TE Contract 2018.02(R) Washington Street Bridge Repair; Award same.

Councilmember Costello moved that the following resolution be adopted, seconded by Councilmember Creighton

<u>RESOLUTION NO.230-18 RE:</u> Award TE Contract 2018.02(R) in regard to the repair of the Washington Street Bridge.

Discussion: Michael Preziosi explained the project and that the work should take about 4-6 weeks. The cost is about \$133,000. Patty Robcke, Town Comptroller, stated that it is a capitol project and they raise money for bridges ever year and put money aside for capitol projects. Michael Preziosi said the cost is slightly higher than estimated but due to the fact of the specialty work and welders.

Engineers have looked at the various options and they say it makes no sense and doesn't do anything regarding climate change. All the rain will back up with these barriers and the ACOE should be urged to think it through.
