OF NOTE:

- Attended several Veterans' ceremonies. **Supervisor Puglisi** stated that all should thank the Veterans for what they've done for the country.
- Members of the Town's Youth Center attended tonight's Town Board meeting. Supervisor Puglisi thanked these members who were the participants of "Making Strides Against Breast Cancer". Jamie Bucci, Assistant Director, commented that \$2021 was raised and she and John Palmietto presented proclamations to the participants.
- Attended the dedication of the Purple Heart Memorial Bridge at Bear Mountain which came to be from Purple Heart Veterans as a request to rename the Bear Mt. Bridge. **Supervisor Puglisi** thanked Assemblywoman Sandy Galef and Senator Larkin for introducing this to the State Legislature and thanked Willy Nazario for lobbying the State officials to make this happen.
- Opening of the Cortlandt Crossing which will bring in more jobs to the community and more tax revenue. The owners, Arcadia, also agreed to do some remedies such as sidewalks, new lamps and new traffic signal at Baker Street.

There will be a very low Town tax increase of .11% for unincorporated Cortlandt for 2019, about \$1.80 for the year. They will be voting on adopting the budget on December 20, 2018.

TOWN BOARD REPORTS

Councilmember Farrell gave his report OF NOTE:

- Attended the Veteran's Day Memorial Service at the Community Center and in Creter at the 5 Corners Veteran's Menument, Both venumell attended and had
 - Croton at the 5 Corners Veteran's Monument. Both very well attended and had meaningful observances. Councilmember Farrell noted that the attitude in the country has turned in a positive direction with respect to Veterans and are deserving of our respect, thanks and gratitude. He acknowledged Celia Grabowick and Dorothy Ferguson and Phil Miller for their constant participation.
 - The Cortlandt Community Rowing Club has put away their equipment for the season. They are looking forward to the Spring.
 - Cleanup of the gas station on Rt. 9A has been completed. This did not cost the Town anything. There are substantial liens on the property and the outcome of that property is unknown.
 - Councilmember Farrell stated he was grateful to DES for speaking with representatives of NY State DOT about the condition of the 9A corridor and the repaving to make the traffic flow better.
 - Wished everyone a Happy Thanksgiving.

Councilmember Creighton gave his report

OF NOTE:

- Stated what an honor it has been to attend the Veteran's Day ceremonies highlighted by the dedication of the Purple Heart Memorial Bridge.
- The Town hosted a Hudson Valley Chamber of Commerce breakfast to work on economic development issues, attended another sponsored by M&T Bank, and the Town also hosted a real estate broker's forum and workshop. Councilmember Creighton commented that the Town is working hard to make sure that economics continue to push forward.
- Congratulated the Hendrick Hudson Volleyball Team for picking up its 14th sectional title in 18 years and also Jamie Strapalino, music teacher from Lakeland School District for his run in the NY Marathon coming in at 118th place overall.
- Commented that Cortlandt had over 50% turnout on Election night.

Councilmember Becker gave his report

OF NOTE:

- Commented on the camaraderie that exists among Veterans.
- Announced that the first of the Town billboards will be removed based on a plan 10 years ago that called for their removal.
- "Taking Care of Business" will be brought back, a TV show where local businesses are interviewed.

PUBLIC HEARINGS

1. <u>RE: Public Hearing to consider</u> adopting a Law to Regulate Solar Energy Systems in the Town of Cortlandt.

(A complete transcript of this Public Hearing is on file in the Office of the Town Clerk.)

The Town Clerk read the Notice of Hearing and presented its Affidavit of Publication from the official Town newspaper.

Supervisor Puglisi called the hearing to order at 7:41 p.m.

Tom Wood explained that the Town Board on May 15th, 2018 adopted a moratorium with respect to solar facilities because they were getting many applications in that they felt needed to be governed by some additional regulations as to their locations. It did not impact the residential installations, they continue. This Local Law that is before the Board tonight would enact certain regulations. He continued to explain the breakdown of the regulations regarding the three Tiers and setback requirements.

He also commented that with the NY State Real Property Tax Law, there are certain exemptions for solar facilities and there's also an ability to utilize a pilot with respect to the taxation of solar panels, particularly in commercial operations. The reason for the pilot is that for the operator fixes certain over a period of time, that they know what their payments are going to be and on the Town side, since the solar panels are movable, there could be a possibility that they would not necessarily be deemed as accessible. If the Town enters into a pilot in the beginning, which they are entitled to require under the real property tax law, that would be beneficial to all the taxing entities involved. The Town must give notice to the applicant they will require a pilot. They are recommending that the Town insert that language into this law and make that a permanent directive that a pilot would be required on those commercial facilities consideration.

Supervisor Puglisi added that they are all supportive of solar energy. It's the way of the future and that they have been involved with New York State who still has incentives available for homeowners.

Councilmember Creighton commented that the Solarize campaign has ended, but the incentives that exist now are through the second generation so there remains generous incentives through the industry.

Scott Savad 153 Mercer St, New York, NY

Asked to have the process explained regarding the setbacks to which Tom Wood responded explaining the Tiers and their setbacks. He added that there was a committee staffed who worked on this. The thought was that if a Tier 3 commercial operation is going to be permitted, and there's an already developed residential community, that perhaps the setbacks should be greater than what would be normally required.

PUBLIC HEARING, (cont.)

Other details regarding the setbacks were discussed. Councilmember Creighton commented that the idea was not to impact the neighborhoods that exist. Those neighborhoods probably expected there would be houses next to them if it was ever developed and to put a solar field might be jarring for them where some people might appreciate it, it depends on your own personal taste.

Councilmember Farrell commented that he appreciated the more conservative setback and that they will give it another go and look at it more carefully. He corrected Tom Wood to revise his earlier statement of 125% of the energy to be the accurate 110%.

Supervisor Puglisi added that they are supportive of new economic growth in our community yet at the same time they have to be cognizent and respectful to residential neighborhoods and the neighbors

A motion was made to close the Public Hearing and adjourn the vote until the December 11th Town Board meeting by Councilmember Becker, seconded by Councilmember Creighton
