Tom Wood, Town Attorney explained that his Public Hearing was to consider an application to rezone property on Crompond Rd. for a facility known as Cortlandt PITCH. The Town

Board and staff have been working with applicant since the last Public Hearing, and the applicant is very seriously engaged in negotiations for a different site in the community for this project. There is currently not an agreement, there are some details to still work out.

Hopefully by the April meeting we will be able to announce that the application is withdrawn.

Linda Puglisi, Town Supervisor stated that they will now entertain comments from the public regarding this matter.
