#### MEETING CALLED TO ORDER

Supervisor Puglisi called the meeting to order at 7:00 p.m.

Supervisor Puglisi led all in attendance in a Pledge to the Flag.

#### **SUPERVISOR'S PROCLAMATIONS & REPORTS**

# **Supervisor Puglisi gave her report OF NOTE:**

Supervisor commented on the Town of Cortlandt's Veteran's Committee, and how active and strong it is. Willie Nazario, Chairman of the committee is a Vietnam Veteran's Purple Heart Recipient. Memorial day is a very important day and is filled with several events in the community. Friday, 5/24/19, 1:30 p.m. the Town of Cortlandt has their annual ceremony of the Community Center on Westbrook Dr. Monday, 5/27/19, 10:00 a.m. the City of Peekskill ceremony, and Monday, 5/27/19, 11:00 a.m. Village of Croton-on-Hudson ceremony.

It is National Police week. Supervisor Puglisi thanked our NYS Police, and Westchester County Police, and all the other police departments in the region.

Coucilmember Creighton and Supervisor Puglisi presented Joshua Anderson, Eagle Scout, Troop 235 with a Proclamation. Joshua explained his project, which was an outdoor learning center at the Furnace Woods Elementary School, his alma mater.

Supervisor Puglisi recognized Johan Esol, a 12 year old Lakeland Copper Beach Middle School, Troop 174, who was in the audience working on his Citizen in the Community Merit Badge.

The month of May is Support your Local Businesses month. There are three new businesses in the Town of Cortlandt. Ace Hardware off of Lexington Ave., the Blue Mountain Tavern on Watch Hill Rd., and the ZenZone Gym on Albany Post Rd., Croton-on-Hudson.

The beginning of the Outdoor concert and movie series at the Cortlandt Waterfront Park in Verplanck will be Thursday, 6/13/19. These events are free to the public.

The Town of Cortlandt received the Westchester Municipal Planning Federation Award for the new Town pool amenities which include the nature trail network system and the miniature golf course.

There will be two individuals appointed to Director of DES, Stephen Ferreira, and Deputy Dir. DES, Brendt Van Zandt.

The amount of paving in the Town this year will be doubled, and will be voted on tonight. It will be about 8.5 miles of roads repaved.

The Cortlandt PITCH application has been withdrawn. The property owner, Martin Russo has agreed to do that, and will be trying to find another venue for this project. He will be exploring a new location near the Hudson River. It will be a public/private partnership, which is a good way to get amenities, businesses into a community and still be able to have the tax revenue.

# **Councilmember Farrell gave his report OF NOTE:**

Councilmember Farrell attended the Cortlandt Engine Co. Memorial Service at the Dutch Reformed Church. This is their 100<sup>th</sup> anniversary. They honored deceased members of the fire company, ladies auxiliary, and others.

The Verplanck Fire Dept. is celebrating their  $90^{th}$  year anniversary. They will be hosting Wing Night on Saturday, 5/18/19 from 6:00 - 9:00 p.m.

The CCRA attended the NYS Scholastic Rowing Championship in Saratoga, NY. They did really well in the competition. The boys double came in second in their heat, and the girls came in 4<sup>th</sup>. The team is growing and becoming more successful and competitive all the time.

# **Councilmember Creighton gave his report OF NOTE:**

Congratulated the teams that competed in the NYS Rowing Championships.

Attended the NYS Federation of Lake Associations in Lake George, NY. The NYSDEC speaks on various issues that are important for our water quality. There are a couple of pilot programs going on now that combat the harmful algae blooms that are plaguing all the lakes across our state.

Attended Shop, Dine, and do Business in Cortlandt with Supervisor Puglisi at the Blue Mountain Tavern, and the Zen Zone grand opening, which he was very impressed with. Councilmember Becker and he went to Rob's Poultry Shop on Rte. 202, and encouraged residents to stop in. He encouraged residents to try to patronize local businesses as much as possible, as with the closing of Indian Point the focus on economic development in the Town is extremely important.

On the agenda the Town will be accepting a donation of property, Attias property, on Sprout Brook Rd., adding 113 acres to the Town's inventory of open space. It includes 20 acres of unrestricted land, which might make a perfect location for the Town to investigate community solar opportunity there.

# Councilmember Becker gave his report OF NOTE:

The closing of Indian Point. The Town has been preparing for this. The Supervisor put together a tasc force immediately upon hearing of the closing. The Town Board has been proactive. Economic development is going to be a key item. There will be an Economic Consultant hired on the agenda tonight. Please continue to support local businesses, which will provide sales tax which comes directly back to the Town.
