Supervisor Puglisi wished all a very Happy Thanksgiving, and reflected on the many things we all have to be grateful for.

The Public Hearing was opened at 7:15 p.m. and closed at 8:55 p.m.

Supervisor Puglisi stated that there will be no vote taken tonight on this issue. It will be adjourned to 1/14/20. So there will be many opportunities to voice concerns, issues, and comments may also be put in writing to be included in the official record. Councilmember Costello made a motion to approve the Minutes for the Regular Meeting held on October 22, 2019 seconded by Councilmember Becker will all voting **AYE**.

- 2. Public Hearing to amend Zoning Ordinance to allow rock crushing on certain properties in the M-1A Zone.
 - a. Close Public Hearing
 - b. Adopt Negative Declaration
 - c. Adopt Resolution

The public hearing was opened at 9:13 p.m.

Tom Wood, Town Attorney explained the Local Law would amend the Town Zoning Ordinance in the M-1A zoning district. There is currently only one in the Town which is in the Roa Hood Rd. area where our Town Sanitation Dept. is located. It would allow a limited amount of rock crushing, up to two 30 day periods per year with various regulations.

Councilmember Creighton made a motion to close the Public Hearing, adopt a Negative Declaration, and Adopt Local Law.

- 3. Public Hearing regarding Floating Billboards in the Hudson River.
 - a. Close Public Hearing

The public hearing was opened at 9:15 p.m.

Michael Cunningham, Deputy Town Attorney explained that this is a Local Law to prohibit billboards from floating in the Hudson River within 1500 feet of the Town of Cortlandt shorelines.

Councilmember Becker added that this is an issue that is paramount to this Board because we've been opposed for at least 10 years to billboards throughout the community. They are an eyesore, and they block our view. We are voting tonight to oppose this with hopes of keeping our Town free of this visual harassment.

Councilmember Creighton stated that the ability for us to be able to enact this Local Law comes from Governor Cuomo's signing of legislation two and a half months ago that essentially gave jurisdiction to the local communities that are within 1500 feet of the shoreline of the Hudson River.

Councilmember Farrell made a motion to close the Public Hearing, adopt a Negative Declaration, and adopt Local Law seconded by Councilmember Costello with all voting Aye.

The public hearing was closed at 9:18 p.m.
