### **MEETING CALLED TO ORDER**

Supervisor Puglisi called the meeting to order at 7:00 p.m.

#### PLEDGE TO THE FLAG

#### SUPERVISOR'S PROCLAMATIONS & REPORTS

Supervisor Puglisi and Councilmember Becker presented a proclamation to Ms. Beth Dorsa. Ms. Dorsa volunteers as the Director of the food pantry at the Holy Spirit church. She has expanded the food pantry outreach, personally delivers food to the needy, and has worked there for over 10 years.

Supervisor Puglisi stated that last Saturday they had a wonderful Pearl Harbor Day in Croton-on-Hudson, a very moving ceremony. It was the 78<sup>th</sup> anniversary of this sad day, where we lost 2400 military civilians.

#### **ROLL CALL**

On a roll call attendance taken by Town Clerk Laroue R. Shatzkin all Town Board members indicated their presence.

# **PUBLIC HEARINGS**

- 1. Public Hearing to consider the adoption of the 2019 Budget.
  - a. Close Public Hearing
  - b. Amend Preliminary Budget
  - c. Adopt 2019 Town Budget
  - d. Authorize the Library Budget

The Public Hearing was opened at 7:16 p.m.

Supervisor Puglisi stated that the hard copy of the 2020 budget in online, and available for public review. The budget process is a lengthy one. All department heads, Town Board members are always working on the Town finances for the community and are very proud of their record for over 28 years. On average during the 28 year period, there has only been a 1 percent Town tax increase during the entirety. The tax increase for unincorporated Cortlandt, which is about 75 percent of the Town is a very low .9 percent increase, which equates to \$15 for the year. The two villages, Buchanan and Croton, are going to have a decrease in their Town cases. Recently the Town has received a AA1 bond rating from Moody's.

Patricia Robcke, Comptroller stated that the preliminary budget is online under the Comptroller's Department. There are two amendments to the preliminary budget. They are decreases in expenditures. The budget will be lowered by \$80,000 in employee benefits. The total budget is \$42,381.423.00. The total tax levy for the year is \$21,786,747.00. The overall tax levy increase is approximately \$162,000, which is .75 percent. Of the overall State mandated 2 percent tax cap the Town is only using about ¼ of allowable levy increase. Overall spending increase is under 2 percent, about 1.86 percent. If you live within the Town outside the Villages the tax increase is less than 1 percent, within the Villages there will be a slight decrease, about 1.2 percent. The average assessed value within the Town is about \$15 per year. The Town debt is below 7 million dollars, which is approximately 1 percent of the constitutional debt limit that the State allows to borrow. The Town has also been putting away \$100,000 per year for the impending closure of Indian Point. There have been many capital improvement projects this year ie, mini golf at Charles Cook Pool, over 3 million dollars in paving/resurfacing, vehicle replacement plan/leasing thereof.

Councilmember Becker made a motion to close the Public Hearing, amend Preliminary Budget, adopt 2020 Town Budget as amended, and authorize the Library Budget, seconded by Councilmember Creighton with all voting AYE.

The Public Hearing was closed at 7:34 p.m.

#### **TOWN BOARD REPORTS**

Supervisor Puglisi announced the Veteran's banner project, and for more information contact Diane Carrol in her office. She stated that the Town social media is enhanced, and the Town is now on Instagram, and Twitter. Winter Wonderland will be held Sunday, 12/15/19 due to the predicted rain.

# Councilmember Creighton gave his report:

**OF NOTE:** 

Councilmember Creighton thanked all for a fabulous budget. It is crucial to attracting economic development in the Town.

The MOD public hearing was opened last month, and the hearing will continue next month.

Peter Harckam, State Senator provided SAM grants to the Town. In addition to the \$100,000 grant for the Cortlandt Waterfront Park. There will also be a \$100,000 grant for the Town Hall fire safety improvements.

The Town Board will be voting tonight on a Special Permit for Dimension Solar, which is solar project on Croton Ave.

# **Councilmember Farrell gave his report:**

#### **OF NOTE:**

Councilmember Farrell thanked all who voted him into office for another term, and looks forward to continuing to work on the Town Board.

The Cortlandt Waterfront Park sea hanger restoration project, and park rehabilitation is something that he looks forward to seeing progress this year.

The mapping of the thousands of acres of open space that the Town has obtained over the years. He is looking forward to developing a program with the Girl Scouts to map these parcels, and make note of all the interesting features that might be contained on them.

He thanked Supervisor Puglisi and Patricia Robcke, Comptroller for their excellent work on the 2020 budget.

# Councilmember Costello gave her report:

Councilmember Becker thanked everyone who voted for him in the November Election, and looks forward to another term.

He also congratulated the new hires and promotions, and mentioned that for the past year he has been serving as the Town Board liaison for the employees.

Supervisor Puglisi mentioned that the swearing in ceremony will be on Sunday, 1/5/20 at 2:00 p.m. at Cortlandt Town Hall, and all are welcome to attend.

Patricia Robcke, Comptroller commented that the resolution regarding the Capital Projects is a blanket resolution. Throughout the year as the Board decides on certain projects, and items that they want use the money for, the Comptroller is authorized to amend the budget at that time. So this is a resolution to cover these budget transfers. The Town is currently operating within a 2 percent margin of the budget, which is really a phenonominal accomplishment.

She also commented on the Bond Resolution for the Charles J. Cook Pool Bathhouse. The Town will be using financing to cover this project.

Michael Preziosi, Dir. DOTS gave an update on the project. The bathhouse is down, and the contractors are diligently working on constructing a new one in the same footprint as the existing facility. They will be launching a project webpage soon that will contain a 3D rendering of what the potential bathhouse will look like. It is anticipated that this will be ready prior to the 2020 season.
