Tom Wood, Town Attorney stated that these resolutions pertain to the Furnace Woods Sewer District and this would provide a sewer line up Lafayette Ave. to the district. The Town was successful in obtaining approximately \$1.5 million dollars of state grants. So these resolutions are to authorize the Town to borrow on behalf of that sewer district. The users of the sewer district will pay the bond back. This is approximately 75 residences and the Furnace Woods Sewer District.

Supervisor Puglisi stated that they are happy to be renewing the library contracts. Our libraries are wonderful, and provide so many services to the community.

Patricia Robcke, Comptroller stated that the libraries are very thankful that they will be receiving a 5 percent increase this year.

Supervisor Puglisi mentioned the resolution for the WISE intern. The student will be from Walter Panas High School, and will be working in the Engineering Department. It is a wonderful program.
