Supervisor Puglisi sincerely thanked all Town of Cortlandt employees. Most offices are currently operating remotely, other than a few essential offices such as Supervisor, Town Clerk, Tax Receiver, and Sanitation services.

Supervisor Puglisi on behalf of her and the Town Board wanted to recognize that this community, including the Village of Croton-on-Hudson and Buchanan always will, and have come together to help each other.

<u>Councilmember Creighton gave his report</u> NOTE:

Councilman Creighton stated that he wanted to echo Supervisor Puglisi's sentiments about Town staff and their dedication, and hard work. He also mentioned, and expressed gratitude for all of the local businesses, hospitals, EMT services and more.

He mentioned how hard the schools, and teachers are working, and the children.

Councilman Creighton attended a very heartwarming parade of all the EMT, EMS, Fire, Ambulance, Police and more in front of the NYP Hudson Valley Hospital on Monday to honor those working, and risking their living for us.

Councilmember Becker gave his report OF NOTE:

Councilman Becker reiterated his gratitude and thankfulness for everyone in the Town of Cortlandt . He stated that he as well as everyone in the medical field have been "re-deployed". . He has taken on a new role by being a liaison to the families who's family members are in ICU. He impressed how unfair the illness is, and how difficult and sad it is to relay medical information, and sometime letting a family say a final goodbye. Hopefully sooner that later their will be vaccination, and drugs available to fight the virus.

<u>Councilmember Costello gave her report</u> OF NOTE:

Councilwoman Costello echoed sentiments, and thanked everybody as well. She also made mention that note that this is a difficult time for all of us, and if someone needs help with something don't hesitate to ask for it.

Councilmember Farrell gave his report OF NOTE:

Councilman Farrell also thanked all of the doctors, nurses, hospital workers, and their families. This has been a major adjustment for all, and people have to realize the be gentle with themselves, and to reach out for help if they need it. The Town website has many resources for people who may be experiencing depression, anxiety, and other issues. He advised people to reach out to family members, friends, and take the time to reconnect with people .

Councilman Creighton commented on the CVE North American Planning Board Application for a Tier 3 Solar Energy system. This is a solar project that is proposed off of Cortlandt Blvd./Rte.6 about 800 feet east of Baker St, and there are number of site development issues, and are seeking the Town's input on the site plan. So this is essentially the beginning of the process for this application. We will be seeking input from our DOTS department.

Michael Preziosi, Dir. DOTS commented on the Lake Meahagh water quality assessment stating that Lake Meahagh has been suffering from a variety of invasive species. This report consists of various treatments for the problem, which will begin in Spring 2020.once the DEC permit is received.

Supervisor Puglisi stated that the Town is receiving comments from the Planning Board regarding the MOD project, and the public hearing is adjourned to the June Town Board meeting.

Stephen Ferreira, Dir. DES commented on the request for stop sign in the Cortlandt Ridge development, there were letters sent to the homeowners that would be affected by the stop sign. Most were in favor of the signage, so there will be one stop sign placed at Sassinoro Blvd. and Chiusa Lane.

Councilman Creighton made a motion to receive and file the above, seconded by Councilman Farrell with all voting **AYE**.

Councilman Farrell made a motion to receive and file the above, seconded by Councilwoman Costello with all voting **AYE**.

Supervisor Puglisi asked Thomas Wood, Town Attorney to give a brief overview of the Hawthorned Devco LLC rezoning.

Thomas Wood, Town Attorney stated that this property is located on Oregon Rd., formerly the Colonial Terrace for age restricted assisted living. This is the initial petition to the Board. The Board will have to decide about the Zoning amendment. Therefore, it is appropriate under SEQR that the Town Board conduct the environmental review as the lead agent So this resolution tonight is to advise staff to notify all the other involved agency of your intention to declare yourself lead agency.

Councilman Becker commented on the subject of the improvements to the intersection of Bear Mtn. Parkway/Crompond Road/Route 202/35. He stated the left turn lane on Rte. 202 and the Bear Mountain parkway is a real choke point for traffic. So when advised by AKRF, who are traffic consultants to the Town, they recommended it might be a good time to ask the State to redesign and make the traffic flow better in that area. By eliminating the left hand turn on the eastbound side of Route 202 would help with the flow of traffic, and eliminate a big safety concern.

Supervisor Puglisi stated that the appointment of Valerie Myers to the Planning Board is to fill the position left vacant by the death of Planning Board member Peter Daley. She was an alternate Planning Board member and will be familiar with the current cases, and a great asset to the Town.

Councilman Creighton stated that the renewal of the contract for George Oros as Economic Consultant is an incredible value to the Town, and he is doing a very great job in this position.

Supervisor Puglisi commented on the new branding logo for the Town of Cortlandt, and thanked Bill Powers, and Peter McKinley for their input.

Patricia Robcke, Comptroller commented on the transfer of funds from the General Fund to the Highway Fund. There was additional sales tax revenue in the General Fund, and it will be transferred into the Highway Fund, as there was a lot of paving in 2019, and this will help to sure up the fund balance in the Highway Fund.

Councilman Farrell commented on the economic state, and wanted to announce that there are funds available to sole proprietors/self employed, who not be eligible for any kind of unemployment benefits. He stated that perhaps George Oros, and Councilman Creighton could work on getting the word out to some of those people.

Councilwoman Costello made a motion to adopt the above Resolutions, seconded by Councilman Becker with all voting **AYE**.

Councilman Creighton stated that he wanted to be sure that Resolution No, 95-20 had a \$10,000 cap on the amount.

All Town Board members agreed.

Councilman Creighton made a motion to adopt the above Resolutions seconded by Councilman Becker with all voting **AYE**.

Supervisor Puglisi stated that the park rangers are part of the Westchester County Police, and are definitely needed for social distancing practice.

Supervisor Puglisi stated that they are delighted to be able to donate money to each established food pantries in the Town of Cortlandt at this time of great need. There are about five of them in the community, so much needed at this time.

REPORTS/COMMENTS FROM VARIOUS DEPARTMENTS

Michael Preziosi, Dir. DOTS stated that the Sherwood Rd. watermain replacement will be going out to bid. The work will begin in the Summer, and most likely last through the early Fall.

The right turn lane at the intersection of Westbrook Dr. and Route 6 where the Kohl's shopping center is. That would be a road widening project where they will place a dedicated right turn lane from Westbrook Dr. onto Route 6.

The remainder is DOTS seeking consultant services for several projects through the end of the year as noted in the resolutions.

Councilman Becker commented on the item to evaluate the Toddville School Building, 3 Locust Ave., and the design services for proposed Cortlandt-Peekskill Regional Paramedic Headquarters. He stated that this was mentioned previously with the Board, and NYP Hudson Valley Hospital, and they donated the old Toddville School Building to the Town for an EMS center. .EMS has inadequately been working out of trailers across from the hospital, and this will be a great new home for our EMS providers. The building has to be evaluated as far as salvaging the building or taking it down, and putting up a new building. As we have learned most recently how important these services are to us, and they are in need of an adequate location and home for our EMS providers.

Thomas Wood, Town Attorney explained that the money for renovation, and our paramedic coverage comes out of the Ambulance District tax on the taxpayer's tax bills. We also share the cost of the program with the City of Peekskill. We all agree that they deserve much better housing for the services that they provide to us.

Supervisor Puglisi stated that she and Councilman Farrell have been working with the Montrose Business Association, and the group Montrose Matters regarding the corridor in Montrose, Albany Post Rd. that there is a need for improvement. It is a NYS road.

Michael Preziosi, Dir. DOTS stated that the decorative lamps have been ordered and will be place when work is resumed in full.

Stephen Ferreira, Dir DES stated that they currently have one sewer pump in Cortlandt Ridge II Pump Station that is not working, and needs to be replaced. So they will be ordering two sewer pumps so that they have a backup for future problems.

Claudia Vahey, Dir Human Resources that they will be appointing 8 DES Seasonal workers, two will be starting soon, and the rest in May..
