#### (RE: NEGATIVE DECLARATION RE: A LOCAL LAW ESTABLISHING A MORATORIUM FOR SPECIAL PERMITS AND SUBDIVISIONS LARGER THAN THREE LOTS)

**WHEREAS,** the Town Board of the Town of Cortlandt has expressed its intent to consider, after conducting a Public Hearing hereon, a Local Law Establishing a Moratorium For Special Permits and Subdivisions Larger than Three Lots; and

WHEREAS, in accordance with the requirements of the New York State Environmental Quality Review Act ("SEQRA"), the Town Board must make a determination as to the Environmental Impact of this proposed action; and

**WHEREAS,** in accordance with 6 NYCRR, Part 617.6, the Town Board is the only Agency required to approve the proposed action, and is therefore the Lead Agency; and

**WHEREAS,** a short Environmental Assessment Form has been prepared, signed by the Supervisor, and accepted by the Town Board; and

WHEREAS, the Town Board has duly considered all of the environmental aspects of the proposed action;

**NOW, THEREFORE, BE IT RESOLVED,** based on a review of the Project, there appear to be no significant adverse environmental impacts; and

**BE IT FURTHER RESOLVED,** that based upon the Environmental Assessment Form submitted to and reviewed by the Town Board, that this is an Unlisted Action; and

**BE IT FURTHER RESOLVED,** that based upon the Environmental Assessment Form, the Town Board of the Town of Cortlandt does hereby **ADOPT** the attached **NEGATIVE DECLARATION** with respect to this matter.

# (A Local Law Establishing a Moratorium for Special Permits and Subdivisions Larger than Three Lots)

### Section 1: Legislative Intent

The Town Board has many zoning districts in the Town. Properties designated as R-80 are often located in environmentally sensitive areas. The Town Board believes it is in the Town's best interest to take a pause on special permits and larger subdivision applications in order to ensure that development is appropriate within areas zoned as R-80.

#### Section 2: Moratorium

No application shall be considered, nor approvals granted, by the Planning Board, Zoning Board of Appeals, or the Code Enforcement officials of the Town with respect to any applications for Special Permits or subdivisions larger than three (3) lots in R-80 Zones.

#### Section 3. Exemption

This moratorium shall not apply to any applications that have already been filed with the Planning Board or Zoning Board of Appeals.

## Section 4. Duration

The moratorium herein shall be effective for nine (9) months from the effective date of this Local Law unless terminated earlier.

## Section 5. Hardship

The Town Board retains unto itself the right to consider variances to this Local Law and to make all determinations with respect to its applicability and interpret and determine the same. Any issues with respect to the interpretation of and variances from this Law shall be determined by the Town Board upon written request of a property owner. This supersedes § 267 of the New York State Town Law as to variance process.

#### Section 6. Severability

If any section or subdivision, paragraph, clause, phrase of this law shall be adjudged invalid or held unconstitutional by any court of competent jurisdiction, any judgment made thereby shall not affect the validity of this law as a whole or any part thereof other than the part or provision so adjudged to be invalid or unconstitutional.

## Section 7. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.

# **RE:** (APPROVE ELECTRICAL REPAIRS AND GENERAL SERVICES FOR THE CORTLANDT SYNTHETIC ICE RINK)

**WHEREAS,** the Town Board of the Town of Cortlandt has previously approved Contract TE 2022.02 and TE 2022.03 covering the purchase and installation of a synthetic ice rink, sheds, storage building and site improvements; and

WHEREAS, to service the new buildings, repair and general electrical service work for the equipment and skating rink were required; and

WHEREAS, multiple proposals were received from Morabito Electric Inc., the Town's on-call electrical contractor totaling Forty-One Thousand Fifty-One Dollars and No Cents (\$41,051.00) which includes installation of conduit, panel upgrades, wiring and installation of electrical fixtures.

WHEREAS, design services to prepare electrical load letter and wiring schematics was requested and a proposal from Lynstaar Engineering P.C. was received in the amount of Nine Thousand Dollars (\$9000.00).

**NOW, THEREFORE, BE IT RESOLVED,** that the proposals from Morabito Electric Inc., be approved at a maximum amount not to exceed Forty-Five Thousand Dollars (\$45,000).

**BE IT FURTHER RESOLVED**, that the Comptroller is authorized to amend the budget and transfer expense associated with Lynstaar Engineering from the Engineering Consultant Line to the Capital Project Line.

**BE IT FURTHER RESOLVED**, that the Director of DOTS is hereby authorized to execute the proposals subject to approval of the same by the Town Attorney.

#### RE: (AUTHORIZE SANITARY SEWER FLOW MONITORING FOR PROPOSED ANNSVILLE CREEK SANITARY SEWER DISTRICT)

**WHEREAS**, Town Board Resolution 273-21 approved a consultant service contract with CPL Arch., Eng. & Plng., to evaluate and design a proposed sanitary sewer district for the Annsville Creek area; and

WHEREAS, the Consultant has recommended after discussion with Westchester County Department of Environmental Facilities and Town of Cortlandt DOTS and DES staff to perform a sanitary flow study to confirm capacity of the existing and receiving, Town and County sanitary infrastructure; and

WHEREAS, the Consultant solicited proposal from qualified firms and recommends award to Fred A. Cook Jr., Inc., P.O. Box 70, Montrose, NY 10548; and

WHEREAS, the total cost including contingency is Twenty-Five Thousand Dollars (\$25,000.00).

**NOW THEREFORE BE IT RESOLVED**, that the previous approved contract with CPL be amended to include the proposed sanitary sewer flow monitoring in the amount indicated above.

**BE IT FURTHER RESOLVED**, that all work is subject to the requirements of NYS Prevailing Wage and CPL shall furnish all lien releases to the Town associated with this work prior to their final payment.

**BE IT FURTHER RESOLVED**, that the cost of said services shall be levied back against the sewer improvement areas.

**BE IT FURTHER RESOLVED**, that the Town Comptroller is hereby authorized to amend the budget accordingly.
