### **MEETING CALLED TO ORDER**

Councilmember Farrell called the meeting to order at 7:00 p.m.

#### PLEDGE TO THE FLAG

Councilmember Farrell led all in attendance in a Pledge to the Flag.

Councilmember Farrell, Deputy Supervisor, explained that he will be chairing the meeting tonight in place of Supervisor Puglisi. He began, along with the help of the Town Board members, by handing out awards to the members of the Youth Center for their participation in "Making Strides Against Breast Cancer" Five Mile Walk on October 15<sup>th</sup>. Katherine Sclafani, Youth Center Director, spoke of how they wanted to match their 2016 fundraiser goal of \$5000. They reached out to businesses and used many ways to raise money, including selling merchandise, snacks, raffle tickets, a 55 inch TV and raised money also individually. This year they raised \$5523, exceeding their goal. Ms. Sclafani commented how proud she is of all the participants and their accomplishments. Offutt Porter, Assistant Director, also commended the youths for their hard work. Councilmember Farrell urged anyone who has not visited the Youth Center to do so as it is a wonderful place with much to do.

<u>Councilmember Farrell:</u> stated that he wanted to recognize the elections that took place last week. Supervisor Puglisi was re-elected along with Councilmember Costello. <u>Councilmember Costello:</u> Recognized and thanked the Veterans for their service along with their families. She wished everyone a Happy Thanksgiving.

<u>Councilmember Becker:</u> Spoke of Dickerson Mountain and trying to preserve the mountain from developers of homes. The Town fought to oppose this project and has been diligent in acquiring this 100 acres of open space. The Town has a large amount of green space that very few communities have which preserve the nature of our Town.

<u>Councilmember Freach:</u> Congratulated Councilmember Becker's determination of preserving the 100 acres of open space at Dickerson Mt. Councilmember Freach commented that it is an important migratory path for wildlife in the community.

Councilmember Freach discussed the resolution that established the Citizen Advisory Committee for the Hudson River Discovery Center at Cortlandt Waterfront Park. He stated it is a wonderful addition and that the Supervisor has been wanting to do this for quite some time and they now have a grant that will fund this. It will be a great resource for the community.

There is still some work being done on the law and some comments received so we asked the Town Board this evening to adjourn this public hearing until January so that some modifications may be proposed to the draft law.
